Quarterly Report for the Period Ended 31 December 2014

Nex Metals Explorations Ltd (Nex or the Company) provides the following update on recent Company activities.

- Yundamindera Exploration Continues.
- Evaluation of various projects.
- Commencement of Legal Action

Yundamindera Exploration

Continuing from previous quarter's activities the Company has continued the review of the Yundamindera Project with consultants and the suitability of a JORC-compliant resource estimation with the intention of follow up drilling for near surface resources. Nex continues to talk to interested parties with respect to the project including sale, Joint Venture, tribute or other commercial arrangement.

Concurrent to activities at Yundamindera the Company has continued its field works at Cosmopolitan/Champion/McTavish and Leipold deposits.

The Company continues to manage the Kookynie Gold project on a fee for service basis with all Nex operational staff and other expenses being paid by the new owners.

Evaluation of Projects

The Company continues to have projects presented to it for evaluation during the past quarter extending from base metals, Iron ore and diamonds.

Commencement of Legal Action

On the 23 December the Company lodged a Writ in the WA Supreme Court wherein the writ claims losses suffered by Nex out of the false and misleading conduct by Stone Resources Ltd (ASX: SHK) in or about October and November 2011 whereby Nex induced by such conduct entered into a Toll Milling Agreement ("the Contract") with the Defendant on or about 29 November 2011 and as a result suffered loss and damage and further as a result of Stone's breach of the Contract Nex suffered further loss and damage.

The Company engaged an independent international accounting firm which calculated the losses incurred by the Company which are significant. At a Status meeting in the Supreme Court subsequent to the end of the quarter the Company disclosed to the Court that after net offs the claim will be in the \$6,000,000 to \$8,000,000 minimum range. The Company expects that Stone will counterclaim in the normal course of events.
